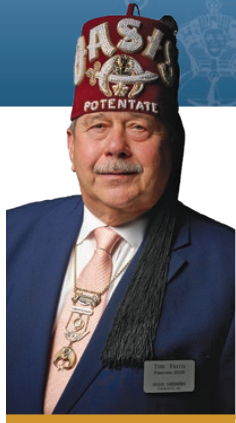

From the Recorder

Hello Everyone,

I hope this note finds you well. This month I will deviate from my articles focusing on our hospital kids and

cover some Oasis business. I will return next month to focus on our all-important Shriner's Children patient stories.

There appears to be some misunderstanding about the actual timetable for paying annual dues (or maybe old habits are just hard to break).

Oasis dues are \$100/year. Added to that number is a Shriners International assessment of \$50/year, and a \$5.00/year hospital assessment, for a grand total of \$155/year. Oasis dues are some of the lowest compared with the other Carolina temples. Let's look at the timeline and try to clear up some common misunderstandings.

Shriners International sent out the 1st email notice for 2026 dues in September of 2025. To not be considered late, 2026 dues needed to be paid by 12/31/25. Beginning 1/1/26, nobles who have not paid their 2026 dues will not be allowed into Oasis functions where dues cards are being reviewed, since your dues help pay for all Oasis functions (i.e. ceremonies, club/unit functions, etc.) **Also, a common overlooked item is that no noble can serve as a club or unit officer in 2026 if they have not paid their 2026 dues by 12/31/25 since nobles in leadership positions are expected to conform to Oasis policies.**

You would have received your 1st dues notice for 2026 in the mail during the timeframe of September-October 2025. Also in October 2025, nobles would have

received a postcard warning that they will be suspended on 12/31/25 if their **2025** dues have not been paid.

In December 2025, nobles received a reminder notice to pay their 2026 dues by 12/31/25 to not be considered "late". Another reminder email was sent in January 2026.

In January 2026, those nobles who let their membership lapse due to nonpayment of 2025 dues, received a "Come Back" postcard. During February 2026, those nobles who still have not paid their 2026 dues will receive a final hardcopy dues notice sent by Shriners International.

Shriners International sends out these late-dues notices, but Oasis is billed for the costs. I believe everyone can see how much expense Oasis incurs for nobles who haven't paid their 2026 dues by 12/31/25.

On a side note, Shriners International will issue new membership cards to nobles once their 2026 dues have been paid. These are permanent cards, are black in color, and show no date. Nobles should present these cards or show an electronic dues card via a phone app entitled "My FezCard Viewer", to gain access to Oasis events.

I hope this explanation clarifies the annual dues timeline. Questions should be directed to Sherrie or to me by calling Oasis at 704-549-9600 and choosing the appropriate area from the menu.

Things continue to go well here at Oasis, and we would love to have your stop by and visit your temple. Take care until next month, and remember, the work you do for our fraternity and philanthropy is sincerely *appreciated* and *essential* to our medical facilities and all our Shriners Children's programs that they serve.

The Making of a Quilt

My father was a mason, a member of Scottish Rite, a Shriner, and a member of the Order of The Eastern Star. As a child I was a patient at Scottish Rite Hospital in Dallas, Texas where I had a very positive experience, and it pleased me that children are still receiving help with their medical issues. Starting my sixth-grade year of elementary school, I was tested and started special classes at the hospital for my dyslexia. It was during our weekly trips to the hospital for my classes that I became interested in understanding more about the fraternity that my father, mother, and other family members belonged to.



When I turned 18 I could not wait to become a member of the Order of The Eastern Star. Years later after being taught to quilt by my grandmothers, aunts, and parents, I was asked to continue that service by making quilts for the Shriners. The first two quilts my dad designed, and my mom and I put them together, sewed and tied them. Both my parents were in poor health, but their work still amazed me. My dad Noble Bob K. Roberts passed

in 2020, and my mom Anita passed in 2022.

In January 2025 I had the pleasure of visiting with Illustrious Sir Tim Farris. He asked if I would consider making a quilt for 2026 in support of the Oasis Sunshine Fund. He asked for a king size quilt, and I knew immediately what colors - everyone knows the colors of a fez! I was given total freedom with my design, so I chose a string quilt pattern.

This allowed me to use the star design that my family members used most often, but in a different pattern that made the star in the center of the quilt stand out. If you look closely, each colored square of the quilt is unique. Each square is made by cutting and measuring each individual rectangular strip of fabric, then sewing rectangular strips of fabric together onto a square piece of interfacing. I used black fabric to strip between the rows of blocks to make the colored fabric stand out. I was able to use most of the same fabric from the first two quilts - you just can't change a good thing!

Lady Betty's *Angel Kids*

Meet Joselyn

Holding the violin donated by the Oasis Pickers to her chin under the bright florescent lights of the Rehabilitation Department at Shriners Children's Greenville, 13-year-old Joselyn runs her bow across the instrument's strings for the first time in two years. She follows the notes played by her rehabilitation aide Cheyenne Pfeiffer, who is also a violinist. Meanwhile, Gemsop, the father of the talented girl, looks on with great pride – and overwhelming emotion.

Tears well up in his eyes as he remembers the music before the accident.

"My stepson went to pick Joselyn up from school on his motorcycle," Gemsop said. "She was taking off her coat as they drove along, with one arm out but the other still in its sleeve. The sleeve somehow entangled in the motorcycle's wheel, instantly taking her arm." And with it, her ability to play the instrument she adored.

Joselyn loved music from a very young age and was a student at the conservatory in her hometown of Pinas, Ecuador. She spent hours practicing and enjoyed performing often at events with other gifted musicians from the school. After the accident, she was fitted locally with a prosthetic arm; however, without a hand that possessed the functionality to hold a bow, it was impossible for her to play.

Then came Shriners Children's Greenville.

"A friend told me about Shriners Children's and thought they could help," Gemsop said.

The timing was perfect. Joselyn had already outgrown her existing prosthesis, and the hospital's Pediatric Orthopedic and Prosthetics (POPS) department knew they could offer more than just a replacement.

"We've made prostheses for kids playing just about every sport you can think of and we've also made ones for patients who play the guitar," said Nate Carter, POPS certified orthotist. "But this was our first time creating one for the violin."



As a violinist, Pfeiffer had accepted the donation of the violin from the Oasis Pickers – the unit comes to the hospital to play music for and with the patients. She offered input to Carter and his team, while Joselyn's occupational therapist (Alex Reynolds) provided additional guidance on creation of a special attachment that would make holding a bow at just the right angle possible.

"It was a team effort," said Reynolds. "It was really important to her to be able to play again, so it was really important to us to work together and figure out how to make that happen."

The morning that Joselyn receives her new device, Gemsop says he is very thankful and knows the staff's efforts are going to make a positive and lasting impact on Joselyn's life. The abundance of gratitude can not only be heard in his words but also seen in the glow of his face – softly smiling as he watches his daughter tentatively play for the first time since she was 11.

The music in their lives has returned.

To the Nobility of Oasis Shriners: In compliance with Item 6 of the "Fundraising Activities" information contained within General Order No. 1, Series of 2024-2025, per the Office of the Imperial Potentate, the following is hereby printed in the temple publication which is annually required. Take due notice thereof and govern yourselves accordingly.

FUNDRAISING ACTIVITIES

Strict attention must be given to all fundraising activities, including but not limited to circuses, gaming, bingo and raffles, to make certain that such activities are authorized and comply with the law of the land. In addition, because it is natural to associate the fez with Shriners Hospitals for Children it is essential that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. Advertising for all fundraisers must clearly indicate the entity for whom the funds are being raised. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

§ 335.3 Use of Name "Shriners Hospitals For Children." The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the chairman of the board of trustees of the Hospitals is prohibited.

§ 503.11 Commercial Use of Name. The use of the name "Shriners Hospitals for Children" or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the boards of directors and trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

1. Fundraising for Fraternal Purposes:

(a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations, shall engage in any fundraising activity without the express written consent of the Potentate of the temple having jurisdiction thereof.

(b) There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.

(c) The temple Potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with §335.3 and §503.11 of the fraternal and charitable bylaws and that there is no representation, expressed or implied, that would lead a reasonably prudent person to believe that the proceeds will be for the benefit of Shriners Hospitals for Children. If the Potentate is in doubt, he must receive the opinion of the Imperial Potentate who, after consultation with the Director of Temple Accounting, shall make the final determination.

(d) The temple Potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and, additionally, as may be required by the temple bylaws.

(e) A copy of the temple Potentate's written consent shall be emailed to the Executive Vice President, Shriners International at officeoftheexecutive@shrinenet.org. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President, Shriners International, shall be promptly mailed to him.

2. Fundraising for Charitable Purposes:

(a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for

Shriners Hospitals for Children. A request to fundraise for Shriners Hospitals for Children is now initiated through a module in WebFez. The temple recorder and/or designated staff are required to take online training to gain access to the module. See updated Charitable Fundraising – Approval and Reporting on page 44 of this publication. Permission therefor must be first obtained in writing or via electronic authorization from the temple Potentate. The temple Potentate must then obtain written permission from the chairmen of the boards of directors and trustees. This request for written permission shall be sent to events@shrinenet.org. No charitable fundraising activity shall be held in the jurisdiction of another temple without the written permission of the Potentate of that temple.

(i) A joint charitable fundraising activity with another 501(c)(3) charity may be authorized, provided that a minimum of 50% of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairmen of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

(ii.) A charitable fundraising activity conducted by a temple located outside of the U.S.A. and Canada may be authorized for other charities, provided that the chairmen of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

(iii.) No charitable funds from a charitable fundraising event may be distributed to charities other than Shriners Hospitals for Children if the written fundraising request and written permission do not specifically include that other charity.

(b) All Shrine temples and their units, Shrine clubs, Shrine Associations and their units and Imperial Sessions of Shriners International are prohibited from engaging telemarketing firms and direct mail firms to assist with fundraising for Shriners Hospitals for Children. No new contracts are permitted without first obtaining written permission from the chairmen of the boards of directors and trustees.

(c) 100% of net proceeds (as defined in the Charitable Fundraising—Approval And Reporting provisions of this General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of any General Order. Provided, however, if the chairmen of the boards of directors and trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution. The remaining net proceeds from charitable fundraising must be given to Shriners Hospitals for Children and may not be designated or restricted in any way other than for research at one or all of our hospitals.

(d) The temple shall report the result of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising—Approval And Reporting provisions of any General Order.

(e) This section shall not apply to activities

exempt under §335.4(b) of the bylaws of Shriners International.

(f) Each independent corporation or entity that receives the permission of the chairmen of the boards of directors and trustees to raise moneys for Shriners Hospitals for Children, and which does not have its financial statements reviewed pursuant to §§334.6 & 337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant and shall submit such audit report to Shriners International within 120 days of the activity.

3. Statement of Purpose and Disclosure:

(a) Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including all electronically transmitted material, regarding the use of the proceeds.

Examples: "Proceeds are for the benefit of (Shriners) (Shrine club) activities." "Proceeds are for the benefit of Shriners Hospitals for Children."

(b) Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on all solicitation material, including tickets, programs, documents and electronically transmitted material, that "payments are not deductible as charitable contributions."

(c) There must be compliance with the Revenue Act of 1987 provision of any general order by U.S. temples.

4. Compliance with Applicable Laws:

It is the responsibility of the temple Potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

5. Financial Records:

(a) The temple shall maintain detailed financial records pertaining to all fundraising activities involving Nobles, clubs, units, organizations of Nobles and affiliated and appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.

(b) The temple must retain such detailed financial records for a period of seven (7) years.

(c) There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any General Order.

6. Notification to Nobility:

A copy of the Fundraising Activities provisions of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be sent to each Noble in the temple not later than the last day in March of each calendar year.

7. Prior Permission:

Every Noble (in his capacity as a Shriner), club, unit, temple, organization of Nobles or affiliated or appendant corporations is prohibited from entering into any telemarketing agreement or contract to raise money for the benefit of Shriners Hospitals for Children without first obtaining written permission from the chairmen of the boards of directors and trustees. This request for written permission shall be sent to the Chief Philanthropy Officer, Shriners Hospitals for Children, at events@shrinenet.org.

8. Discipline:

Any officer, Noble or temple which violates a provision of Fundraising Activities is subject to discipline pursuant to the bylaws of Shriners International.

9. Shriners International Education Foundation:

Notwithstanding the previous provisions of FUNDRAISING ACTIVITIES stated above, Nobles may contribute, encourage other Nobles to contribute and engage in charitable fundraising activities directly to Nobles and their families for the benefit of the Shriners International Education Foundation.
